ORDER GRANTING JOINT MOTION TO CONTINUE

Appeal No. 21-06-EQB was filed with the West Virginia Environmental Quality Board (“Board”) on June 23, 2021. In accordance with West Virginia Code §22B-1-7(f), an evidentiary hearing concerning matters as more fully set forth in the Notice of Appeal filed in Appeal No. 21-06-EQB was scheduled for August 11-12, 2022.

On July 22, 2022, the parties filed a Joint Motion to Continue the evidentiary hearing and extend the stay currently in place for a period of ninety (90) days. Finding it proper to do so, the Board GRANTS the Joint Motion to Continue. The evidentiary hearing in Appeal No. 21-06-EQB shall be continued to the Board’s **November 9-10, 2022** docket. Said hearing will begin at 8:30 a.m. at the Board’s offices located at 601 57th Street, SE, Charleston, Kanawha County, West Virginia.
