NOTICE OF STATUS CONFERENCE

A Status Conference in the above-referenced matter is scheduled for **Thursday, December 14, 2023, beginning at 8:30 a.m.** before the Board's Chairman and legal counsel. The purpose of this status conference is to provide the Board information on the following:

1. The permit conditions under which the Appellant is currently operating;
2. Justification for the stay currently in place;
3. Are the terms of the permit being enforced?;
4. Answer any and all questions the Board may have regarding the permit Appellant is operating under;
5. Answer any and all questions the Board may have regarding the permit modification currently being processed by the West Virginia Department of Environmental Protection.

All counsel shall appear in person at the Board's offices located at 601 57th Street, Charleston, Kanawha County, West Virginia 25304. A Court Reporter will be present for the Status Conference.

It is Ordered that counsel for all parties provide the Board with a Joint Status Report on or before close of business (5:00 p.m.) on December 1, 2023. Each counselor representative attending the status conference is required to have a thorough knowledge of the case, be prepared to discuss the case, and provide the Chairman and legal counsel the current status of the matter. At the conclusion of the conference, either orally for the record or by separate writing, an order will be entered which recites any action taken and agreements reached by the parties. The order will take the place of all that has gone before and will control the subsequent course of a potential hearing unless modified to prevent manifest injustice.
