

**ORDER GRANTING
WEST VIRGINIA RIVERS COALITION'S PETITION TO INTERVENE**

Pending before the Board is a petition by West Virginia Rivers Coalition pursuant to W. Va. Code § 22B-1-7(e) to intervene in the above-captioned appeals. The appeals concern WV/NPDES Permit No. WV0005339 and Order for Compliance No. 7004, certain terms and conditions of which were stayed by the Board by order dated June 17, 2011. The Board finds that West Virginia Rivers Coalition is "affected" by the pending appeal and has otherwise satisfied the requirements for intervention. Counsel for Appellant opposes West Virginia Rivers Coalition's petition, counsel for Appellee does not.

WHEREFORE, the Board hereby GRANTS the petition and directs the Clerk to add West Virginia Rivers Coalition as a party to this appeal.
