ORDER FOR CONTINUANCE AND NOTICE OF HEARING

Appeal No. 22-04-EQB was filed with the West Virginia Environmental Quality Board (“Board”) on July 14, 2022. An evidentiary hearing concerning matters as more fully set forth in the Notice of Appeal filed in Appeal No. 22-04-EQB is scheduled for March 14, 2024.

At a prehearing conference on February 29, 2024, it was represented that issuance of the permit modification in Appeal No. 22-04-EQB, which is currently being processed by the WVDEP, will inform the issues set forth in the above-styled appeal. Therefore, a continuance of the evidentiary hearing has been requested to allow sufficient time for said permit modification application to be processed and issued.

Based on the representations of the parties, the Board does hereby order that the **evidentiary hearing in Appeal No. 22-04-EQB shall be continued until the May 9-10, 2024**, Board meeting. Said hearing will begin at 8:30 a.m. at the Board’s offices located at 601 57th Street, Charleston, Kanawha County, West Virginia 25304. Parties may appear in person or remotely. 
